CENTER-BASED SERVICES WERE PROVIDED AT MESA DOWNTOWN AND RED MOUNTAIN SENIOR CENTERS. ALMOST 17,000 MEALS WERE SERVED ON-SITE OR THROUGH CURBSIDE PICK-UP TO OVER 900 OLDER ADULTS.
